Important Notes for Fund Redemption

- A Fund Redemption Fee (up to 5%) will be levied by PCSec on your redemption transaction, deducted directly from your securities trading account.
- PCSec will receive a trailer commission, if any, which is a commission rebated by the securities issuers based on the net asset value under management of units in the securities arising from your subscription.
- 3. Redemption proceeds will be deposited into your securities trading account.
